Houses of Resistance

In February of this year, Jeff Halper and Salim Shawemreh, members of The Israeli Committee Against House Demolitions (ICAHD), toured across Canada and the United States in an effort to raise awareness about the Palestinian home demolitions being carried out by the Israeli government in the Occupied Territories. Mr. Shawemreh's home had been demolished twice by the Israeli Authorities on account of not having the appropriate building permits; permits, nearly impossible for Palestinians to obtain. Each time Salim has rebuilt

CEPPal co-sponsored their talk in Edmonton on Feburary 8^{th} about the on-going injustices facing the Palestinians, such as house demolitions, and the reasons why Barak's "95%" offer was in fact nothing short of an open-air prison sentence for the Palesintians.

On April 4th, after returning from their Canadian tour, the all too familiar scene repeated itself for Salim. For a third time, workers frantically removed the Shawemreh Family's furniture before the Israeli bulldozers arrived. Mr. Halper's efforts to stop the bulldozer were unsuccessful and a local Rabbi was arrested for using his car to block the bulldozer. Eventually, the home was completely demolished this time the foundations were ripped up and trenches dug under the house to prevent its rebuilding.

Since 1967 some 7000 Palestinian homes have been destroyed on the West Bank, in Gaza and in Arab East Jerusalem, more than 2000 since 1987, leaving 30,000 people homeless, destitute and living in fear and trauma. The work of ICAHD and other organizations has made a difference: in 1999 "only" about 100 homes were demolished, down from 277 in 1998. Yet 2000 demolition orders remain outstanding in the West Bank, another 2000 for East Jerusalem, altogether threatening some 6000 families.

The motivation for demolishing these Palestinian homes is nothing short of intimidation. Although an elaborate system of planning regulations, laws and procedures gives it a legal facade. The goal is to confine the 3,000,000 residents of the West Bank, East Jerusalem and Gaza to small, crowded, impoverished and disconnected enclaves, thus effectively foreclosing any viable Palestinian entity and ensuring Israeli control even if the Palestinians achieve some form of internal "autonomy."

Canada, must denounce: the massive expropriation of Palestinian lands for Israeli settlements, by-pass highways and industrial parks, closures and all forms of economic warfare such as the Israeli government's uprooting of hundreds of thousands of Palestinian fruit and olive trees, exploitation and depletion of Palestinian natural resource, environmental degradation (as Israel has moved its most polluting industries to the West Bank), as well as house demolitions.

CEPPal sends its deepest condolences to the Shawemreh family as well as the 18 other families whose homes and public school were cruelly demolished on April 4, 2001. Peace through justice will prevail.

PAST EVENTS

Right to Return Rally April 7, 2001 Edmonton, Alberta

On Saturday April 7, CEPPal along with 136 other organizations worldwide, staged a rally and march in support of the Palestinian refugees' human right to return to the land that they fled over 53 years earlier when Israel invaded Palestine. The United Nations has endorsed the return in resolution 193 which states: "...the refugees wishing to return to their homes and live at peace with their neighbours should be permitted to do so at the earliest practicable date." This UN resolution was passed in 1948, 53 years ago.

Over 150 Edmontonians of varying religions and ethnic backgrounds showed their support at the rally which commenced at E.A. Corbett Hall at the University of Alberta campus and made its way along Whyte Avenue. The march ended at the Strathcona Farmers market;

"How many poets, scholars, and atheletes have been born and died in the refugee camps and we will never have known of them?" the crowd of listeners, was asked. The event was covered by CBC and the A-Channel.

Article 13 of the Universal Declaration of Human Rights states: *"Everyone has the right to leave any country, including his own, and return to his country."* The return of the refugees is their human right.
